- Extreme events in BiH: floods, droughts, heatwaves, storms, hail
- Direct impacts: risks to human lives, food security, infrastructure and economy

- Process coordinated by MoFTER with UNDP / GCF support
- 1,300+ representatives involved across all levels of government
- Comprehensive analysis of risks, vulnerabilities and sectoral adaptation measures

- Adaptation Fund: STAZA project (USD 10m) resilience in agriculture
- UNDP / EU4AGRI (EUR 23.15m) rural/agriculture suppor
- World Bank: Agriculture Resilience & Competitiveness Project (matching grants)
- EU IPA II/III: ≥ EUR 314.9m (environment, climate action, rural/agriculture)
- Interreg IPA: cross-border agro-tech projects (~EUR 6.4m)
