


- An updated interim overview on the Significant Water Management Issues in the DRBD to be addressed in the 3rd DRBM Plan

- Providing aid for the development of a target-oriented 3rd DRBM Plan and updated Joint Programme of Measures by 2021



- Next step: additional update for the workshop in October 2019









Status of proposal development



- Eol submitted on 5th March (deadline 8th March) for 3rd call of DTP
- Official support by ICPDR through resolution of Ordinary Meeting in December 2018
- Official support by EUSDR Steering Group of the Priority Area 4
 through Letter of Recommendation (February 2019)
- Invitation to submit a full proposal (3rd October)
 - reconsideration and justification of monitoring costs
 - reformulation of project specific objectives
 - redistribution of tasks between partners (less responsibility for LP)


