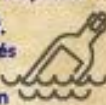

Thematic WPs:

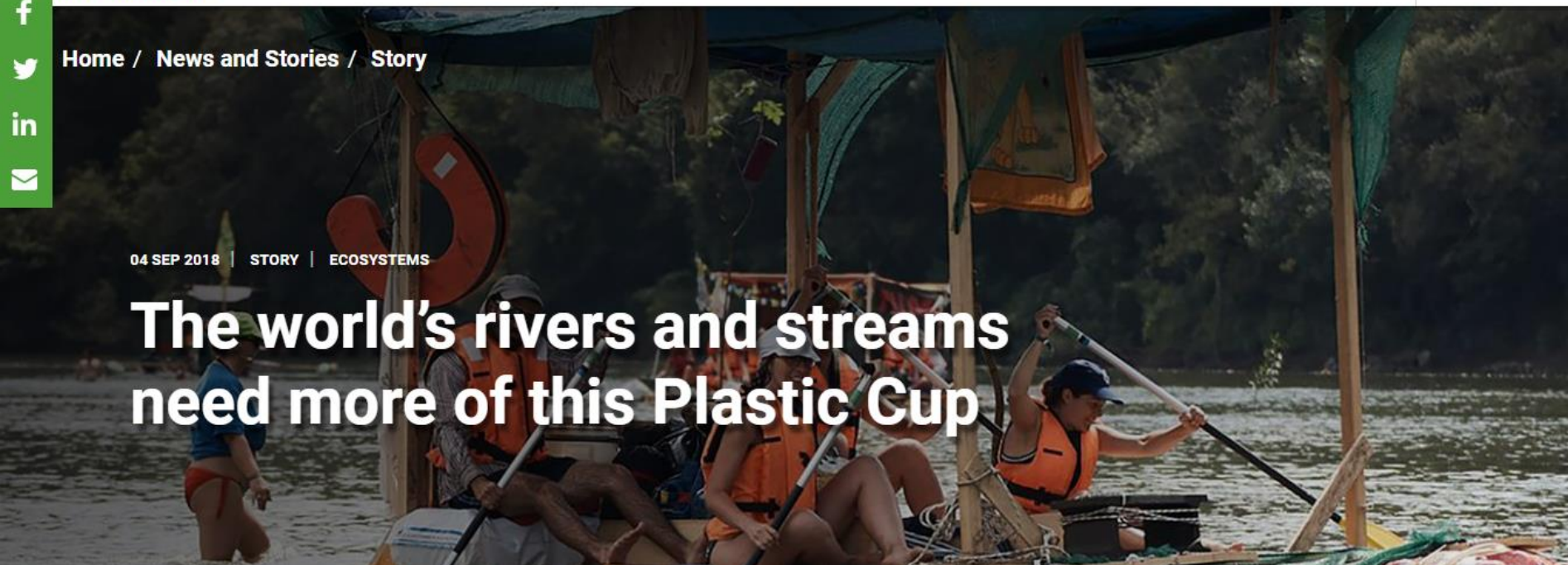
1. Waste localisation and strategy for collection: micro- and macroplastic monitoring and sampling based on JOINTISZA JTS Manual and ICPDR JDS4. Transnational strategy for the improvement of river water quality.
2. Pilot actions for awareness raising: pilot clean-up actions in the Tisa sub-basin and at the Danube downstream the Tisa estuary
3. Involvement and legislation: local and transnational forums for policy discussion, and handbook with inputs to ASPs and (sub-)basin management plans
4. Dissemination: Media, movies and floating awareness raising exhibition

With the project we hope to contribute to the EUSDR PA4 targets and to the work of the ICPDR. We would like to elaborate and contribute to the basin management plans of Danube and Tisa with sound knowledge and experiences on plastic pollution in order to tackle the problem effectively.
