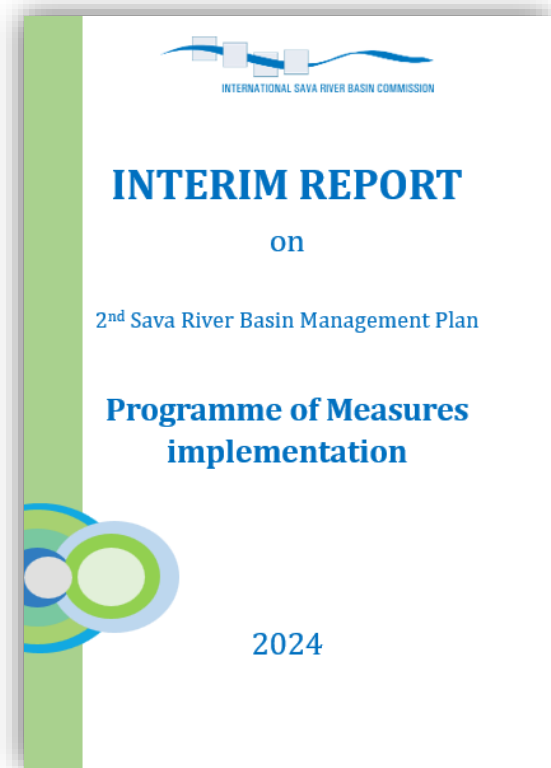

 - Preparation of **Interim Report on PoM implementation** - *ongoing*
 - To be approved in December 2024
 - Gaps identified in the 2nd Sava RBM Plan are planned to be addressed through **SDIP**

- **Sediment issues**
 - Report on planned dredging for 2024 - *prepared*
 - Report on executed dredging for 2023 - *prepared*
